## Contract, Release and Waiver of Liability and Indemnity Agreement

The Original MMA Martial art is a physical activity; uncontrolled or careless contact such as punching and kicking is not permitted. In spite of care, precaution and concern, accidental injury may occur by the very nature of the activity. Any student's use of excessive force or disregard for the safety of others in class will result in dismissal from the class. Any student who exhibits behavior, conduct or attitude considered to be detrimental to Red Dragon, its instructors or students will be dismissed from class.

In consideration of being permitted to participate in Red Dragon Kajukenbo, LLC's martial art classes, tournaments, training and events, and to enter the facility of Red Dragon or such other facilities as may be utilized by Red Dragon from time to time, for any purpose, including, but not limited to, observation of martial art classes, use of facilities or equipment, or participation in any way in martial art classes, tournaments, training and events, the undersigned, for themselves, their child their ward and any personal representatives, heirs and, next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering will, inspect the facilities and equipment. It is further agreed and warranted that any such entry into such facilities for observation, participation or use of any facility or equipment for any Red Dragon martial art classes, tournament, training or event constitutes an acknowledgement that all such facilities and equipment thereon have been inspected and that the undersigned finds and accepts the same as being safe and reasonably suited for the purposes of such observation or use.

In further consideration of being permitted to enter Red Dragon and such other facilities as may be utilized by Red Dragon from time to time, for any purpose, and in consideration of being permitted to limited to participate in Red Dragon martial art classes, tournaments, training and events in any way, including but not limited to observation and use of the facilities or equipment, the undersigned hereby agrees to the following:

- 1. The undersigned, on their own behalf and on behalf of their minor child or ward, hereby release, waives, discharges and covenants not to sue Red Dragon and their directors, officers, employees, agents, instructors or other students (hereinafter referred to as "Releases") from all liability to the undersigned, their minor child or ward, their personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim demands, or therefor on account of injury to the person or property or resulting in death, arising out of or related to martial art classes, tournaments, or events, or travel to or from any class, tournament, or event, whether caused by the negligence of the releases or otherwise.
- 2. The undersigned hereby agrees to defend, indemnify, and save and hold harmless the Releases and each of them from any claim, loss, liability, damage or costs they may incur arising out of or related in any manner to their, or their child or ward's, participation in Red Dragon martial art classes, tournaments or events, or travel to or from any class, tournament, or event whether cause by negligence of Releases or otherwise.
- 3. The undersigned hereby assume full responsibility for an risk of bodily injury, death or property damage to the undersigned or their child or ward, arising out of or related to Red Dragon martial art or ward's, participation in Red Dragon martial art classes, tournaments or events, whether cause by negligence of Releases or otherwise.
- 4. The undersigned further expressly agrees that the foregoing Contract, Release and Waiver of Liability and indemnity Agreement is intended to be as broad and inclusive as permitted by the law of the State of Idaho and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned has read the contract, Release and waiver of Liability and Indemnify Agreement, understands the rights he or she is giving up by signing it, has signed it freely and voluntarily without any inducement, assurance or guarantee being made, and intends his or her signature to be a complete and unconditional release of all liability.

- Classes times can change, check calendar for upcoming changes, if any.
- All fees are due by the 1st or 15th of each month (pre-paid). \$10 Late Fee after 7 days of due date.
- Dues are applied month to month <u>only</u>.
- New contract and start-up fee is required after 90 day or more absence.
- \$25 start-up (per family) Fee is waived with the pre-paid plans.
- There will be no refunds or transfers of fees paid toward lessons.
- There will be a \$20 charge for all return checks.
- Authorized continuous EFT will continue to charge the card on file monthly until written request (5 day minimum)
- School uniforms are required at the cost of \$50 paid to Red Dragon (School Shirt, Black Pants & Belt).
- Sparring equipment and safety gear is required and can also be purchased at Red Dragon Kajukenbo.
- All students must buy their own uniforms within 30 days of enrollment (see cost below).
- Promotions for students will vary depending on many factors, see handbook for details. You will be required to
  pay a promotion fee of \$30 or \$20 depending on belt level (includes belt). A customized belt is available at an
  additional cost.
- This school will observe all legal holidays, including additional days (see calendar for events and closures)
